

A–F Accountability Rating System Updates: 2027 Ratings

A–F is a tool to help meet continuously improved goals for students.



There are several key design commitments built into A–F to help ensure it works as an effective continuous improvement tool while accurately recognizing performance:


- 1. Ratings reflect better of achievement or progress
- 2. School performance is evaluated through multiple valid measures
- 3. Ratings are based on defined criteria, not a fixed distribution
 - "A" reflects performance consistent with reaching long-term student goals
 - "C" reflects average performance for the baseline year
- 4. The system design remains static in most years

A–F Design Commitment: The system remains largely unchanged year to year. 2027 is a static year.

The A-F system remains the same for 5 years.



We don't keep changing the bar, as this allows for better year-over-year comparisons. But we continuously review feedback to make design changes once every five years.



New HB 8 Implications

- 5-year refresh now explicitly codified
- The commissioner cannot raise cut scores outside of the refresh cycle
- Refresh rules must be communicated two years before the refresh (Adopt Manual Late Summer 2026)
- What-if ratings must be provided for those two years (2026 and 2027 What-Ifs)

* Modified or no ratings issued due to COVID-19

In 2027, the A–F Accountability System remains static.



- There are no changes to cut points, domain, or indicator methodology for 2027 accountability ratings.
- The rules for the 2027 accountability year have been previously adopted and are re-adopted as annually required.
- The manual will be open for public comment on December 12, 2025.


The manual is anticipated to be effective in early April 2026.

New HB 8 Implications

- Annual rules that will be applied for that school year must be communicated by July 15
- Refresh rules must be communicated two years before the refresh (Adopt Manual Late Summer 2026)
- What-if ratings must be provided for those two years (2026 and 2027 What-Ifs)

Previously adopted upgrades in effect in 2027.



- There are no changes to cut points, domain, or indicator methodology for 2027 accountability ratings.
- The rules for the 2027 accountability year were previously adopted and will be re-adopted as annually required.
- Previously adopted updates in effect in 2027:
 - Programs of Study and Industry-Based Certification (IBC) Alignment: College, Career, and Military Readiness (CCMR) credit will be earned on 2027 accountability for successfully earning an approved IBC from either the 2022-25 list (with sunsetting limit) or the 2025-30 list, with CTE Completer status in an aligned program of study.
 - College Preparatory Course Requirements: College, Career, and Military Readiness (CCMR) credit will be earned on 2027 accountability for those courses meeting requirements aligned between districts and the partnering IHEs taken by students who were in their 12th grade year.

Reminder: CCMR Credit through an IBC and Aligned Program of Study



Phase-in of IBCs and Alignment with Programs of Study

Approved IBC List: Earning an approved IBC from v3 (2022-2025) or v4 (2025-2030) list receives CCMR credit on 2027 accountability. This is the last year to report v3 IBCs. v3 IBCs are subject to a sunsetting limit. **Program of Study Phase-in (CTE Completer):** The earning of an approved IBC also requires earning CTE Completer status in the career and technical education program of study aligned with that IBC.

Reminder: CCMR Credit through College Preparatory Courses



Phase-in of College Prep 12th Grade Requirement and Reviewed and Approved College Prep Courses

College Preparatory Grade 12: Only courses completed in the 12th grade are eligible for CCMR credit through college prep. The grade of the student at the time of the course will be based on the grade submitted in the TSDS PEIMS Summer submission. A student must be in the required grade at any time during the school year when the course credit was received.

Approved College Preparatory Course List: Beginning with annual graduates from the Class of 2027 (2028 accountability), only college prep courses from the approved list will be eligible for CCMR credit.

 Additional edits to the Accountability Manual are made to support educators and to reflect stakeholder needs.

- To further refine the accountability appeals process, the following revision was made:
 - A granted Closing the Gaps appeal can update comprehensive, targeted, or additional targeted support intervention federal identifications.

Legislative Update: County District Campus Number (CDCN)



- TEA assigns county-district-campus (CDC) numbers to instructional campuses as defined in the Texas Education Data Standards. Within any given year, districts or charter schools may need to update one or more CDC numbers due to closing old schools, opening new schools, or changing the grades or populations served by an existing school.
- In accordance with anticipated changes to 19 TAC §97.1066, the deadline for campus requests outlined in the 2027 Accountability Systems Manual has been moved from September 1 to May 31.

Key Points and Summary of Changes



- The manual for 2027 accountability ratings re-adopted prior methodology.
- The manual for 2027 accountability ratings has an adoption date **before** the 2026-27 school year.

Summary of A-F Changes:

- Programs of Study and Industry-Based Certification (IBC) Alignment: College, Career, and Military Readiness (CCMR) credit will be earned on 2027 accountability for successfully earning an approved IBC from either the 2022-25 list (with sunsetting limit) or the 2025-30 list, with CTE Completer status in an aligned program of study.
- College Preparatory Course Requirements: College, Career, and Military Readiness (CCMR) credit
 will be earned on 2027 accountability for those courses meeting requirements aligned between
 districts and the partnering IHEs taken by students who were in their 12th grade year.

Changes Related to A-F:

- Related to Federal Identification: A granted Closing the Gaps appeal can update comprehensive, targeted, or additional targeted support intervention federal identifications.
- Related to campus number requests: In alignment with anticipated changes to 19 Texas
 Administrative Code §97.1066, the campus request deadline reflected in the 2027 Accountability
 Rating System Manual is May 31, moved from September 1.
