



Now Available CCMR Tracker Release: Stage I

To the Superintendent Addressed:

The purpose of this communication is to provide information regarding the release of the College, Career, and Military Readiness (CCMR) Tracker. The CCMR Tracker is released in two stages through [TEA Login \(TEAL\) Accountability](#).

Stage 1: March 31, 2023

- CCMR indicators submitted via PEIMS through the 2021–22 school year
- OnRamps and TSIA results through 2021–22 school year
- SAT, ACT, AP, IB and level I/II certificate results through the 2020–21 school year

Stage 2: July 2023

SAT, ACT, AP, IB and level I/II certificates updated through 2021-22 school year

Background

The CCMR Tracker is a tracking tool within the [TEA Login \(TEAL\) Accountability](#) application. This tool provides districts with an early preview of CCMR status for students who are in grades 9–12 during the 2022–23 school year. **The CCMR Tracker contains lagging data as is detailed in the chart below.** While the Tracker contains students who were in grades 9–12 on the 2022–23 PEIMS snapshot, the 2023 version does *not* contain results from school year 2022–23 as those data have yet to be reported.

Indicators are credited if earned within date ranges provided below for students beginning with grade 9 enrollment. TSI assessments are the only CCMR indicator that may be earned prior to grade 9. Indicators reported upon graduation (IEP and workforce readiness graduates and special education graduate with advanced diploma plan) do not appear in the Tracker.

The table below provides the years included in the CCMR Tracker for each indicator and release.

Corrections cannot be submitted to TEA; this report is for informational purposes only. If districts find errors, they are encouraged to work with testing vendors to make corrections prior to the student’s graduation. TSDS PEIMS data are final and cannot be corrected.

The 2023 CCMR Verifier, which will provide districts an opportunity to verify CCMR data given to the agency by outside testing entities for 2021–22 annual graduates and non-graduating 12th graders, will be released in the TEAL Accountability application in July.
