

2026 College, Career, and Military Readiness (CCMR) Tracker Part I

The CCMR Tracker Part I provides districts with a means to track CCMR indicator completion throughout high school for students reported as enrolled in grades 9–12 on the TSDS PEIMS Fall 2025 snapshot date. New for 2026, the CCMR Tracker also includes 2025 annual graduates and non-graduates attributed to the district.

The CCMR Tracker is for informational purposes only. PEIMS errors may be corrected through a Working Submission that meets the requirements and follows the process outlined in the [Guidance on PEIMS Working Submissions for CCMR Data](#) communication. Non-PEIMS data for 2025 annual graduates and non-graduates can be corrected via the CCMR Verifier, to be released later this Spring.

The 2026 CCMR Tracker is released in two stages:

- Part I - April 2, 2026: CCMR outcomes reported through TSDS PEIMS, TSIA results, and OnRamps course completion through the **2024–25** school year; SAT, ACT, AP, IB, and level I/II certificate results through the **2023–24** school year
- Part II - Summer 2026: CCMR outcomes for SAT, ACT, AP, IB, and level I/II certificate data are updated to include results through the **2024–25** school year

Note: the CCMR Tracker contains lagging data. While the CCMR Tracker contains students who were in grades 9–12 on the 2025–26 PEIMS snapshot and who were 2025 annual graduates and non-graduates, it does *not* contain results from the **2025–26** school year, as those data have yet to be reported.
