School Health Policies and Procedures (Ill child being sent home)

We believe that healthy kids learn better! LISD School Health is committed to helping you keep your student healthy, in school, and learning. This takes a team effort. Please let us know how we can assist your child with any health needs.

Family Access: Through Family Access, parents can use the internet to review all their student’s health records. You can go to the Lampasas ISD website and log in to view information for health services like your student’s immunization record and office visits. To get your password and gain access to Family Access, please contact the campus office for your student.

Exclusion Policies (General & COVID-19): Lampasas ISD follows the Center for Disease Control and Texas Department of State Health Services guidelines for communicable diseases in a school setting. Students being sent home due to exclusion policies must be picked up immediately. Symptoms requiring exclusion from school (sent home or absence):

- Fever of 100.4° or greater (please do not give fever-reducing medications to send student to school).
- Vomiting (unrelated to overeating, exercise, anxiety, or other non-infectious triggers).
- Diarrhea (unrelated to documented pre-existing gastrointestinal issues).
- Yellow discharge from the eye – pink eye
- Ringworm of the scalp
- The first 24 hours of antibiotic treatment for infections such as pink eye, strep throat, etc.
- New, undiagnosed rash or skin condition, at the nurse’s discretion, until verified by healthcare provider that it is not contagious.
- **COVID-19** symptoms: (fever, cough, shortness of breath, loss of taste and/or smell, sore throat, weakness, muscle pains, headache, chills)

Your child is being sent home from school for _____ on _____ (date) at _____ (time). Your child must be symptom free for 24 hours without medication before returning to school for non-COVID related illnesses.

- Any student sent home by the school nurse for symptoms consistent with COVID, must provide a note from their provider with the date they are allowed to return to school.
- In partnership with AdventHealth FMC, rapid COVID testing (BinaxNOW COVID-19 Ag Card by Abbott) will be made available for symptomatic students after assessment by the school nurse. Please call the clinic at (512)-556-3621. Tell them your student is with LISD so they can schedule the rapid test. These tests are free (insurances will be billed for the visit with provider as well as for any additional required testing.) This note **MUST** be presented to AdventHealth FMC for rapid testing.
- If your student has stayed home and is symptomatic, call the clinic to schedule, and tell them it is for a student at LISD. They will contact the school to verify enrollment.
- If student is tested for COVID, please notify the school nurse immediately.
- If student has been on quarantine for COVID, they must have a clearance from a physician and/or the Local Health Authority with the date they are allowed to return to school.
